Govt suspends new WFI panel, says was run from Brij Bhushan's premises

MIHIR VASAVDA Mumbai, December 24

THREE DAYS AFTER the Wrestling Federation of India (WFI) elections, the Union sports ministry on Sunday suspended the newly-elected committee of the governing body. The reason for the action is the conduct of the WFI's erstwhile president and BJP MP Brij Bhushan Sharan Singh, whose tenure got over earlier this year and who has been charged by Delhi Police with sexual harassment of six women wrestlers.

Sharing details of the ministry's action, an official said that despite the formation of the new body, the WFI affairs were being conducted from Brij Bhushan's premises "wherein sexual harassment of players has been alleged" and he "appears to be in complete control". The official further said that the WFI panel led by Sanjay Singh, who had earlier said that Brij Bhushan was like his "brother", had demonstrated "blatant disregard for established legal and procedural norms".

The government has put the Indian Olympic Association (IOA) in charge of carrying out the day-to-day affairs of the WFI "until further orders". This is the second time this year that

the IOA has been handed over the responsibility to govern domestic wrestling.

In a letter to IOA president P T Usha, Under Secretary Tarun Pareek wrote: "I am directed to refer to this Ministry's order... abstaining the newly-elected Executive Committee of the WFI from administering and managing the day-to-day activities of the Federation."

Pareek added: "...taking note of the compelling current situation arising out of the influence and control of the WFI's former office-bearers, serious concerns have arisen about the governance and integrity of the WFI. This requires immediate and stringent corrective measures to uphold the principles

of good governance in sports

organisations."

The ministry's decision comes on the back of strong objections raised by some of the country's top wrestlers against the outcome of the elections. And it means Brij Bhushan's close aide Sanjay Singh will not be involved in the

Speaking to reporters at Ranchi airport, Singh said: "I was on a flight so haven't seen the letter yet. Once I read it, I'll be able to comment. I have heard that they have stopped my activities. What activities, I will check and comment on."

In New Delhi, following a meeting with BJP chief J P Nadda, Brij Bhushan told reporters that he will stay away from the sport now.

"I served wrestling for 12 years, good or bad only time will tell. I have taken retirement from wrestling. I am breaking my relationship with the sport. Now whatever decision has to be taken, whether to liaise with the government or handling the legal processes, those decisions will be taken by the elected members now. The Lok Sabha elections are round the corner and I have to move ahead," he was quoted by *PTI* as saying. The statement marks a

complete U-turn from election daywhen Brij Bhushan was recommending timelines to conduct competitions and said he would be open to giving suggestions to the new body.

Last Thursday, the panel backed by Brij Bhushan and led by Singh assumed control of the Wrestling Federation of India, which is still suspended by the international wrestling federation after its muchdelayed elections took place in controversial circumstances. Singh defeated former Commonwealth Games gold medallist Anita Sheoran in a one-sided election.

Minutes after his appointment, Singh met Brij Bhushan at his official residence, which also doubles up as the WFI office.



Samajwadi Party (SP) leaders paid tributes to Charan Singh in Lucknow. Former CM and party chief Akhilesh Yadav quoted the former PM, saying "Desh ki khushhali ka rasta khet aur khalihan se ho kar gujarta hai (The path to the nation's happiness passes through farmlands)."

The Congress dedicated the fourth day of its ongoing UP Jodo Yatra to Charan Singh as it passed through western UP's

Bijnor district. State Congress president Ajay Rai, who held meetings with a section of Gujjar and farmer leaders in Muzaffarnagar on Friday, offered tributes to the farmer leader.
